## ABOUT ME

My name is Angela Carson, I'm the foreign tourist to explore Balochistan the longest since 9/11. Over 3 trips in 2021 and 4 trips in 2024, I explored 10 districts over 72 days. In 2021, I launched 24 travel videos to some of Balochistan's most remote and beautiful places. In 2024, I launched Balochistan's first-ever series of luxury tours with the aim of enticing non-backpackers to visit the region.


In 2024, I moved back and setup a company with the goal to help grow awareness & demand for tourism in Balochistan. I was approved by PTDC's CEO Aftab Rana to rebrand Balochistan Tourism, including a new website, modern logo, and world-class social media targeted to foreigners. The only requirement from PTDC was that the funding for the project needed to come from Balochistan's budget. Farah Azeem Shah had agreed to fund the project.

On a trip to meet with Farah Azeem Shah and various government officers to Quetta, I met a man who would later try to rape me.


## PLEASE NOTE:

1. **REASON FOR THIS COMPLAINT:** I recently learned that Fawad has 2 open cases for rape in Balochistan and that he has had other complaints by women he's abused dismissed by "friends in high places". I am told he is a known trafficker of young women. I AM REQUESTING AN INVESTIGATION BE OPEN INTO THOSE PENDING CASES to stop Fawad for hurting more young women in the future.
2. **NO PROOF:** I have no proof as he is very careful but I will lay out verifiable facts and share my WhatsApp history from the day we met, up to his attack on me, and immediately following it.

3 April 2024 | Quetta Serena Hotel lobby



- I was sat working in the hotel lobby when a man came up and introduced himself as a coordinator to CM Bugti, passing me this business card. I had been trying to secure a meeting with CM Bugti – who I engaged with briefly during the 2022 floods when I made a video shining a light on Balochistan's suffering, when he was the Governor – so I instantly trusted Shahnawaz knowing he worked for the CM. He was illegally / falsely using that card still, as I discovered that he was Coordinator when Bizenjo was CM:

- He asked why I was there and I told him about my PTDC-approved project of uplifting Balochistan's image and about the other meetings I had that trip. He asked if I wanted to meet Commissioner Hamza Shafqat and I said YES but I didn't have my security team there at the moment and he said it wasn't needed if I was with him.
- He swept me off in his vehicle within minutes. Later I realised he used me to get in to meet face-to-face with Hamza. He pushed me through security and into the Commissioner's small back office room, walking past 10 men sat in Hamza's office. I assumed he had that power because he worked for CM Bugti.
- On the drive back to Serena, he told me something I will never forget: "I'm here to make money, I don't care about anything else," which was the OPPOSITE to what my feelings were. I wanted to help Baloch people in rural areas. I was spending my own money self-funding my company as I tried to secure funding for my project.
- He also told me that his CONDITION for helping me was that I never mention his name. But I didn't know him or trust him so I asked 2 people I trusted at the time if they knew him, [REDACTED] and Farah Azeem Shah, [REDACTED] didn't know him but said 100% don't trust him and Farah assured me "u r in safe hands with Fawad".
- That afternoon he sent me a video of himself with the ex-CM Bizenjo in a private plane, a photo with Asif Ali Zardari, shared pics of guns & alcohol, and we chatted. I am a private

pilot and enjoy cocktails so for me I felt he was someone I could have fun with.



- That night at 22:39 he messaged me saying he learned I asked Farah about him, which he told me was “forbidden”. He said to never contact him again.

### 13 July 2024

- After 3 months of being told “yes, next week” by Farah Azeem Shah, I realised the funding for my project was not coming. I contacted Fawad, still believing he had a direct line to CM Bugti and he could help get funding greenlit for my project.
- He asked how much money I had in the bank and I told him (not a lot), so he said he was going to send his secretary to drop me an envelope to de-stress me. I assumed it was some advance payment from the project funding from CM’s office or some other government entity but later I realised he was paying me as if I were a prostitute. I sent him my address at One Constitution Avenue in Islamabad and his sec dropped off an envelope at 18:49 (████████████████████ 18:30).



- We agreed to meet at Islamabad Serena Hotel lobby the next day but then he called 2 hours later and said his plans had changed and he only had 5 minutes that evening so he would come hear my project pitch quickly. My business partner (████████████████████) was at my apartment for a meeting, which I told to Fawad. He said he didn’t have time for the formality of a group meeting and to ask him to leave so I did.
- He arrived at 20:56 and asked for a tour. In my bedroom he asked me to turn on AC, which I thought was strange and just said “no no, we’ll meet in my living room”. He instantly took my hand in his and said that he hoped I understood things work differently

in Balochistan and that I needed a man to fund my life. I still stupidly thought I was there to pitch for funding and had my laptop. He suggested we go sit on my bed. Again, I said no, and asked to show him my project. He reached over and started kissing me instead.

- I've never dealt with this before but now fully understand how women are blamed as being complicit. In that moment of shock and disbelief, it felt safest for me to give in a little and then move, sit away from him or stand with an ottoman between us. As weak as this sounds, I didn't want to offend him or bruise his ego. I fully believed he was in a position of power with CM and I needed him to approve my project.
- **Then, it was a nightmare. Over the course of 35 minutes, he pinned me against a wall twice, exposed his penis and tried to push my head down onto it, he shoved his hand down my bra and cupped my breast, kissed me multiple times.** At every moment, I pushed him off, distanced myself, tried to get back to showing my project presentation, and said NO.
- When I finally got him out the door, he put his shoe in the door frame to stop it from closing and pushed back in. **That was the first time I went from being very annoyed and worried to being TERRIFIED AND SCARED.**
- After he left I made 2 calls to tell people what happened: to my [REDACTED] and then to my mother for 3 hours. She was so upset to hear what had happened in my pursuit of getting that project funded that she offered to fund it for Balochistan! I never accepted her offer.
- I also sent [REDACTED] and my Islamabad-based lawyer details about Fawad (name, number, card, chats, etc) out of fear for my safety "just in case"

## 14 July 2024

- After the attack, he messaged & called non-stop.



- He dangled the funding for my passion project over my head, asking me a few hours after the attack to send the financials from my project.
- I played nice, still in shock but also trying to not hurt his ego or make an enemy. I still fully believed he could fund my project. I told him how he made me feel, like a prostitute and cheap. The ONLY message I received from him that acknowledges the attempted

rape in some way is below (14 July 2024, 23:45):



In the months that followed

- He gaslit me, convinced me I misunderstood his advances. He pursued me.
- 31 August he said he had a serious project he wanted me to work on (and I really needed work). He asked me to meet him at RIMS HOSPITAL INTERNATIONAL (Jinnah Road, Blue Area Islamabad). It wasn't a project, he lied. In a boardroom, he tried to impress me by having me meet the top physicians and hospital administrators – and I quickly learned they thought I was going to be an investor. All lies. In the middle of the meeting I stood up and excused myself and left that situation and never saw him face-to-face again.
- I blocked him on WhatsApp finally mid-November.
