LEGAL NOTICE

Subject: Cease and Desist Notice Regarding
Defamatory Allegations

Madam,

Under the instructions of my client Mr. Syed Shahnawaz, I hereby serve you with this legal notice as under:

1. That it has come to the knowledge of my client that you have made false, frivolous, baseless, and defamatory allegations against him, both privately and publicly, including through the medium of your WhatsApp communications and other social media platforms.

2. That you have publicly accused my client of serious criminal offences, including attempted rape and involvement in illegal activities, without any lawful proof or evidence whatsoever. You yourself have admitted that you possess no proof and that your complaint is based on mere assumptions, hearsay, and unverified information.
3. That your malicious and defamatory statements, including but not limited to the baseless allegations shared publicly, have caused severe damage to the reputation, goodwill, and social standing of my client in the public, professional, and social circles.
4. That it is also brought to your attention that my client reserves the right to institute civil and criminal proceedings against you for these grossly defamatory statements, including the

initiation of a suit for defamation under the relevant laws of Pakistan, wherein a claim for damages amounting to Rs. 5 Crores (Fifty Million Rupees) shall be sought against you for causing irreparable loss to the reputation and dignity of my client.

5. That you are hereby called upon to immediately cease and desist from making, publishing, or spreading any further defamatory, false, or malicious content against my client, whether in person, on social media, or through any other platform, directly or indirectly.
6. That you are further required to tender an unconditional public apology to my client within SEVEN (07) days from the receipt of this notice, and to prominently publish the said apology on all your social media accounts and other platforms where such defamatory allegations were made.


7. That in case of your failure to comply with the above demands within the stipulated time, my client shall be compelled to:
- a. File a civil suit for defamation seeking damages of Rs. 5 Crores.
 - b. Lodge a formal complaint with the Federal Investigation Agency (FIA) against you for cybercrime, harassment, and character assassination under the applicable laws of Pakistan.
 - c. Initiate all other legal remedies available to my client under civil and criminal law at your sole risk, cost, and consequence.

This notice is being sent to you without prejudice to all rights and remedies available to my client under the law, which are hereby expressly reserved.
